Your booth number will be placed on the back of this letter and returned to you, along with your confirmation and instruction sheet, no later than July 15th, 2010. To expedite your check-in, you must have this letter available to show craft personnel on the days of the show. Do **NOT** throw it away: after you set up your booth, please display the number along with your resale certificate conspicuously in your booth.

The Sayville Fire Department has asked us to issue the following rules for crafters. Please keep in mind these rules are necessary to secure the safety of fellow crafters and of those who attend.

Upon arrival unload your vehicle first; park your car, return and then set up. This will keep the streets clear. If an emergency should occur, access will then be possible.

Sidewalks must remain clear of vendor's stock. Sidewalks must be accessible. You may walk back to your vehicle for additional items or store them in your booth.

**SAYVILLE SUMMER FESTIVAL 2010-RAIN OR SHINE**

The Greater Sayville Chamber of Commerce will be having their annual Summer Festival on Saturday and Sunday, August 7th and 8th 2010. The festival will take place out of doors and will encompass the entire downtown area of Sayville. This is an extensively advertised event which draws very large crowds. We would like to invite you to join our artists and crafts people in an exhibition and sale of their work as part of the Summer Festival. The following are the Festival guidelines:

- Booths **MUST** be set up by 8:30AM show time is 9:30AM to 6:00 both Saturday and Sunday.
- The fee for the two (2) day festival is \$175.00 for a 10-foot wide by 10-foot deep outdoor space.
- This is an **OUTDOOR** event. We are at the mercy of Mother Nature and therefore could be subject to inclement weather. Due to the size and nature of the event, weather conditions are monitored by officials. If it is determined that inclement weather is passing the event will continue as planned. It is **IMPERATIVE** that all vendors bring tarps or other materials to protect their merchandise as temporary unpleasant conditions may prevail. Event personnel will keep you advised.
- All crafts **MUST** be handcrafted by the submitting craftsperson.
- Two photos will be requested along with the application and check. One photo should show an example of your work and the other your display booth.
- There are four (4) specific prize awarded craft categories from which you are to indicate which one you are entering in.
  - 1) Floral Art: Handmade florals, silk, dried and shells or other.
  - 2) Fiber Arts: Soft Sculpture, quilts, pillows, crocheting, basketry, rug making and related fabric items. **NO COMMERCIALY SEWN PRODUCTS WILL BE ACCEPTED.**
  - 3) Woodcrafts: Handmade wooden items, painted or plain, functional or decorative. Absolutely **NO STORE BOUGHT ITEMS.**
  - 4) Sculpture: Ceramic, stained glass, metal-smithing, stone, jewelry. **NO COMMERCIALY PRODUCED JEWELRY WILL BE ACCEPTED.**

The Chamber of Commerce reserves the right to request the removal of any work it deems objectionable for any reason. No imported or kit produced items will be accepted. Your official resale certificate must be on display at all times during the festival. We are limited to 140 spaces and are working on a first come-first served basis by postmark date. Your immediate response will be in your best interest and your space designation will follow at a later date. There are **NO REFUNDS**, for any reason, once the Committee accepts your application for a spot. Please bring confirmation of assigned space with you. Without it, you may not get into your space.
